Elements of Risk: The out-of-school and educational activities and sporting events offered involve certain elements of risk. Accidents may occur while participating in out-of-school activities that may result in injury. These accidents result from the nature of the activity and can occur without any fault on either the part of the student, the school, its employees, or agents or the facility where the activity is taking place. The chance of an accident occurring can be reduced by carefully following instructions at all times while engaged in the activity. In the event of overnight trips, there is possibility that reasons beyond our control such as inclement weather may be cause for the trip to be extended or cut short. There is an element of risk that the trip may be longer than reflected in the above information.

Private Motor Vehicles Transportation and Insurance: Oakville Christian School recognizes that private motor vehicles may be used for some out-of-class trips. All volunteers must complete the **Authorization to Transport Students Form** and must have a completed **Criminal Reference Check** on file with the school office. Oakville Christian School requires all drivers to have a minimum of \$1,000,000 third party liability insurance coverage.
